ON THE 15th DAY OF March, 2016 AT 9:44 PM THE DEFENDANT,
 AT 433 MELROSE AV, GREEN COVE SPRINGS, FL 32043 WITHIN CLAY COUNTY, VIOLATED THE LAW AND DID THEM AND THERE:

On the listed date and time officers responded to 433 Malrose St. in reference to a disturbance where a battery possibly occurred.

Upon arrival, I observed two male subjects (the Def and Weiland Short) standing the front yard of 433 Malrose St. with another male subject standing between them. The male standing in the middle (Waylon Woods) appeared to be keeping the two males from fighting. It should be noted, Mr. Short is the Def's girlfriend's father. I separated all subjects. I attempted to speak with the Def to find out what occurred and he kept stating that his girlfriend had his vehicle's keys and he just wanted to leave. I smelled the strong odor of alcohol from the Def breath. While I was trying to speak with the Def he kept yelling "you" at Mr. Short who was across the yard. Mr. Short was yelling back but he stopped when I instructed him to stop talking. When I was telling the Def to stop yelling and to speak with me about what happened, he continued yelling "you" and other things to Mr. Short. The Def ignored my instructions and became irate by continuing to yell. I again told him to stop yelling but he continued. The Def advanced toward me in an aggressive

fighting manner (as if he were going to get me out of his way and go to Mr. Short). I told him to back up multiple times and quiet down. Sgt. Whiddon approached and moved the Def backward to obtain a reactionary gap. The Def advanced at Sgt. Whiddon and I in an aggressive way with his fists balled in a punching manner. The Def refused to comply with officer's demands to back up and stop yelling. Several times Sgt. Whiddon moved the subject backward to obtain a reactionary gap and each time the Def would advance forward aggressively still yelling at police. Several times the Def jumped and flensed forward at Sgt. Whiddon in an attacking manner as if he was about to fight police.

Sgt. Whiddon advised Ofc. Patrick to take the Def into custody. Ofc. Patrick placed the Def in handcuffs and into the back of his patrol car.

The Def's girlfriend (Valorie Short) stated an argument started when she refused to give the Def his keys to leave. She stated he had been drinking alcohol all day and became very violent. She didn't want him to drive the vehicle while he had been drinking. She stated when she wouldn't give the keys back, he grabbed her wrist and shoved her aggressively against the basketball hoop pole. She stated he was screaming at her to "give me the keys". Mrs. Short stated he held her against the pole with his forearm and elbow on her neck. She stated she was yelling "get your hands off me". She stated he dropped her to the ground when the Def saw Mr. Short approaching from the home next door (431 Melrose Ave.). Mr. Short was yelling at the Def to get his hands off of Mrs. Short. She stated the two were "in each others face" about to fight but Mr. Woods intervaned.

It should be noted, the Def and Mrs. Short have been dating approximately two years. The two do not reside in the same home, nor do they have children in common.

The Def was placed under arrest for battery (dating violence) and resisting officers without violence.
