On 05-28-15, at 0015 hours, Sgt. J.A. Weeks #6777, Officer T.C. Hall #64808 and I arrived at 3551 Bowden Circle E. in an attempt to arrest a subject with two active warrants (71487/ 282964).

The front gate to the property was closed and secured with a chain and lock. For several minutes we observed the residence from a vacant lot across the street. I observed an outdoor motion sensor light turn on along the southern side of the house located at 3537 Bowden Cir. E. This property borders the suspect's property on the northern side. Seconds after the light activated, I observed the suspect running in his neighbor's yard, along the fence line that borders his property. The suspect was running from the back yard toward the street. He jumped the fence that is positioned along the front yard of his neighbor's residence (victim #2). While jumping the fence, it appeared he broke the top rail. The suspect then began walking along the ditch line between his fence and the road. Sgt. Weeks, Ofc. Hall and I emerged from the vacant lot and Sgt. Weeks shouted "Police!" The suspect, who had a knife in each hand turned toward Sgt. Weeks and was approximately 12 feet away. The suspect was squared up to Sgt. Weeks with a tense grip on each knife. The suspect turned toward his property and began to flee on foot. The suspect jumped his front gate and ran toward his house. In doing so, the suspect led officers directly through areas of his property in which he had recently placed boards with 4 inch nails facing upward. These boards were partially buried in the sand and out of sight. Sgt. Weeks yelled loudly several times to stop running and drop the knives. The suspect ran to the left of his truck, which was parked near the front of the house. He turned toward Sgt. Weeks with both knives still in his hands. As Sgt. Weeks closed the distance between him and the suspect, the suspect ran around the front of his truck and toward a camper parked on the southern side of the property. I ran to the left of the truck and observed the suspect fall to the ground. He turned onto his back and as Sgt. Weeks attempted to effect an arrest, the suspect kicked Sgt. Weeks in the chest, leaving a sandy boot print on his uniform shirt. Sgt. Weeks and I gave the suspect several loud commands to show us his hands. While attempting to handcuff the suspect, he resisted by turning onto his stomach and placing his hands underneath his chest. Sgt. Weeks delivered several strikes to the super scapula area of the suspect in an effort to gain control of the suspect's wrists. I struck the suspect several times in the common peronial area and lower back. After several strikes, we gained control of his wrists and applied

handcuffs.

The suspect did not suffer any injuries during the apprehension and did not require medical attention. Two knives the suspect was in possession of were located near the front of his truck on the ground. Post Miranda,

I made contact with Mr. Eichenlaub. He showed me the damage to the his fence caused by the suspect jumping over it.

The suspect was arrested and transported to the Pre Trial Detention Facility. Crime Scene Detective T. Sellers #5665 arrived to photograph the location of the knives and the boot print on Sgt. Weeks' uniform shirt. Officer Hall collected the knives and placed them in the Property Room.

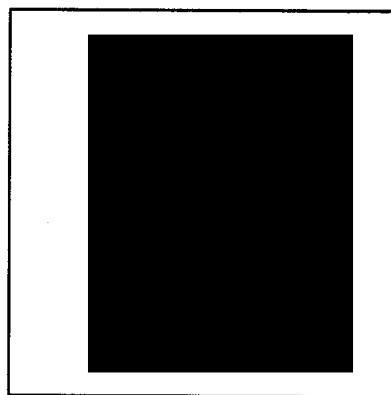
