

Before me the undersigned Judge of the Fourth Judicial Circuit, in and for Duval County, Florida, personally came **Detective D.K. Scott #7714** who, being duly sworn deposes and says that he has reason to believe and does believe that one **Williams, Gloria B.**, described as follows: Last Known Address: **914 N. Lemacks St. Walterboro, SC.** Race: **Black** Sex: **Female**; DOB: **11-20-1965**; Ht: **5'04"**; Wt:148 pounds; Hair:Black; Eyes:Brown; Scars, Marks: Unknown; did in Duval County, Florida, on or between the **10th** day of **July, 1998 and the 9th day of July 2016** commit the crime(s) of **Kidnapping, and Interference with Custody,** contrary to the provisions of Section(s) **\$787.01(1)(A)2, and \$787.03(1)** Florida Statutes. Affiant's reasons for so believing are as follows:

Your affiant is a detective with the Jacksonville Sheriff's Office with fifteen years experience. Your affiant is currently assigned to the Investigations Division / Homicide.

On July 10th, 1998, the victim, Kamiyah Mobley, was born at university Hospital (currently known as UF Health Jacksonville), located at 655 West 8th Street, Jacksonville, Dural County Florida. Within hours of the victim's birth, a black female (suspect) both the victim from the hospital room, without parental consent, and disappeared with the victim. The suspect was unknown to the mother, and the mother believed that the suspect worked in the hospital. The suspect was not an employee of the hospital. Despite all efforts police were unable to locate the victim or the suspect until this year. The mother of the victim never had custody of Kamiyah Mobley after her abduction.

On August 8th, 2016, an anonymous tip was received from the National Center for Missing and Exploited Children, which provided information that the victim was currently residing in Walterboro, South Carolina. The tip stated that the victim told her friend that the victim was kidnapped when she was a baby, and is listed as a missing person. The tip said that the victim is currently named Alexis Kelli Manigo.

On November 8th, 2016, another anonymous tip received from the National Center for Missing and Exploited Children, provided information that Gloria Bolden Williams (suspect) admitted to taking the victim from a hospital in Jacksonville, Florida. The tip stated that the suspect stated that she renamed the victim as Alexis Kelli Manigo, and claims her as her daughter. The tip further stated that they are both currently residing in Walterboro, South Carolina.

On January 10th, 2017, Detective G.L. Warkentien and Detective M.M. Rhatigan arrived in Walterboro, South Carolina. A birth certificate and social security card for Alexis Kelli Manigo was obtained from Colleton County High School. Further investigation of these documents revealed that the birth certificate was fraudulent, as well as the social security card. The social security number listed with Alexis Kelli Manigo name was issued to a male in Virginia, who died in 1983.

Detective Warkentien and Detective Rhatigan also interviewed a witness who provided a . swoṛn statement that approximately a year and a half ago, suspect confessed to him that she "stole" a baby from a hospital in Jacksonville, Florida, and that baby is Alexis Kelli Manigo.

A second witness was interviewed by Detective Warkentien and Detective Rhatigan, who provided a sworn statement that approximately a year and a half ago, Alexis Manigo told her that she had been kidnapped from a hospital in Jacksonville, Florida when she was a baby. Alexis said her mother, Gloria Williams (suspect), told her she was Kamiyah Mobley.

Detective Warkentien obtained oral swabs from Alexis Manigo. The swabs were submitted to FDLE for comparison to Kamyiah Mobley's DNA which was collected and preserved from her birth. The results determined that Alexis Manigo's DNA matches Kamyiah Mobley's DNA.
