

# SEARCH WARRANT

In the Magistrate Court of Camden County  
State of Georgia

Docket # CR-9-18-006

TO: ALL PEACE OFFICERS OF THE STATE OF GEORGIA

Affidavit having been made before me by ASAC Richard Dial, an officer charged with the duty of enforcing the Criminal Laws, that he or she has probable cause to believe that in Camden County, Georgia, on the following described person, premises, or property:

An Apple iPhone X, marked with GBI Evidence/Property Tag AA62725. Said Apple iPhone X is currently in the possession of Agent Dial, located in Camden County, GA.

There is now located certain instruments, articles, persons, or things, namely:

Electronic logs, records, files, messages, and data contained on the internal memory, on Subscriber identification module (SIM) cards, and other electronic media storage devices, to wit:

1. Records of numbers dialed and incoming numbers;
2. Push-to-talk and direct dispatch information, originating and terminating with the above-described device;
3. Subscriber or owner information to include the communications device numbers, mobile device numbers (MDN), electronic mail addresses, or other unique identifiers assigned to the above-described device, and billing and transactional data;
4. Unique device identifiers including model numbers, electronic serial numbers (ESN), international mobile equipment identifiers (IMEI), mobile equipment identifiers (MEID), and Unique Device Identifiers (UDID);
5. Subscriber Identity Module (SIM), International mobile Subscriber Identifier (IMSI), and Integrated circuit chip identifiers (ICCD);
6. Media access control (MAC) addresses and internet protocol (IP) addresses assigned to the device or any peripheral device attached thereto;
7. Image files, which are evidence of the below listed crime(s) or which can be used to identify the user of the device;
8. Movie files; which are evidence of the below listed crime(s) or which can be used to identify the user of the device;
9. Records of text messages sent from or to the above-described device, and the content thereof, which are evidence of the below listed crime or which can be used to identify the user of the device;
10. Records of electronic mail messages sent from or to the above-described device, and the content thereof, which are evidence of the below listed crime or which can be used to identify the user of the device;;
11. Global positioning system (GPS) or location data that can be used to place the device in a specific location, which is more commonly known as:
12. Databases containing records of data uploads and download sent from or to the above-described device;
14. Information listed in the electronic address book including but not limited to cellular communications device contact information; names, communications device numbers, addresses, electronic mail addresses, other electronic addresses, or any other identification information of others;

15. Media access control (MAC) addresses, network identification information or name, location data, and internet protocol (IP) addresses for any device or cellular site to which the device or any peripheral device attached thereto communicated;
16. Geolocation data to include information obtaining using global positioning system (GPS) transceivers or ranging data using cellular telephone service provider networks.
17. Electronic records, PLists, Extensible Markup Language (XML) documents, databases, electronic logs, electronic documents, other similar journals, or other electronic files, documenting the time, date, duration, electronic addresses, communications device numbers, and other unique data associated with any communication event sent to or received by the above described device; and
18. Metadata or other electronic data associated with or which describes any data, information, or file listed herein.

All of the above records stored in the internal memory of the above-described device, on any external memory or media storage device attached thereto, or on any third-party "cloud" computing server used by any application being used or accessed by the above-described-device in whatever format stored.

Which are evidence of or being possessed in violation of the laws of the State of Georgia, to wit:

Aggravated Stalking (OCGA § 16-5-91)

Based upon the affidavit given under oath or affirmation and all other evidence given to me under oath or affirmation, I am satisfied that there is probable cause to believe that a crime is being committed or has been committed and that the property described above is presently located on the person, premises, or property described above.

You are hereby commanded to enter, search and seize within ten (10) days of this date, the person, premises, or property described above. A copy of this Warrant is to be left with the person searched, or if no person is available, on the premises or vehicle searched, and a written return, including an inventory of any things seized, shall be made before me or a Court of competent jurisdiction without unnecessary delay after the execution of this Search Warrant.

Furthermore, Affiant or his or her designee is hereby authorized to remove the above-described electronic device from the jurisdiction of the Court, and to bring that device to specially trained and equipped personnel for examination and analysis.
